- V. ATA News**
  - a. Don Williamson reported that Lynn Gipson had passed away and will be replaced by Randy Meullar.

A notification was sent to the shoot organizers informing them of the decision.
- b. It was decided to hold a monthly remote BOD meeting on the second Wednesday of each month at 7pm, starting on Wednesday May 13.
- c. Walter to purchase Zoom subscription for ASTA use for all meetings going forward.
- d. It was also decided that the board will require the Treasurer to provide a monthly financial statement prior to the monthly call. The Finances will be reviewed at the monthly meetings.
